## COMMITTEE UPDATES/REMINDERS

### Perinatal Review Reminder:

Please be reminded that midwives are required to refer cases involving the following criteria to the CMM Perinatal Review Committee for review:

- all stillbirths (> 500 grams)
- neonatal deaths (> 500 grams to 28 days of life inclusive)
- maternal deaths
- specified morbidity in neonates and mothers

If you/your practice group have charts that are audited by the CMM Quality Assurance Committee as part of its Quality Assurance program, and applicable cases are identified, they will be automatically forwarded to the CMM for review.

### Quality Assurance Update:

The Quality Assurance Committee recently met (February 2nd). Members expressed sadness to see Cara McDonald resign from the Committee and at the same time welcome He Hu. A big thank you to Cara for her work with the Committee over the years! The draft Terms of Reference were finalized and will require Council approval before inclusion in the CMM Bylaw. You will receive a copy once this occurs. The Committee will soon appoint auditors for the 2010-2011 audit, appoint the QA Panel members, and set the date for the full practice site review. The practice audit tools are being tested in a mini audit being conducted at Mount Carmel Clinic. More information to follow.

### Providing Care to Family Members, Colleagues and Friends

Over the years some midwives have requested direction from the CMM regarding providing care to family members, colleagues or friends. Midwifery has traditionally provided intimate care, and the midwife/client relationship develops in a safe comfortable environment that engenders trust and mutual respect. When providing care to a member of her own family, colleague or friend, a midwife must acknowledge the pre-existing relationship may impact the development of such a relationship. In cases where either party feels the pre-existing relationship may be detrimental to the care of the client, then the client should be referred to another midwife or care provider. The midwife and her family member, colleague or friend must be aware of the potential difficulties maintaining the necessary professional boundaries while in a midwife/client relationship. Boundary violations can result when there is confusion between the needs of the midwife and those of the client. It is important that the midwife stay focused on the needs of each particular client regardless of any pre-existing relationship and ensure that she can provide quality midwifery care. In addition, the midwife should consider her own ability to provide appropriate care in emergency or difficult situations, and should consider having a 'back-up' care provider in case she becomes unable to provide care. In all cases the client should be recognized as the primary decision-maker.

### Midwifery Outcomes: Data Is on the Horizon

The Health Information Management department of Manitoba Health has been working on compiling the data collected from the Midwifery Discharge Summary Forms and producing reports regarding midwifery outcomes in Manitoba. All practices should have received information from Manitoba Health about submitting Discharge Summary Forms in June, 2010. In addition a notice was distributed in December, 2010 regarding possible backlogs of Discharge Summary Forms from 2008/2009. If you have not received either of these communications please contact the CMM. The goal of Health Information Management Branch is to produce quarterly reports beginning in the near future. ### NEWBORN SCREENING

*Cadham Provincial Laboratory has recently introduced new Newborn Screening Cards. They are experiencing increased rates of insufficient samples and would like to remind care providers to ensure that the fold-over flap is extended out of the way when taking a sample to ensure that blood does not soak through to the flap itself. The Midwives Association of Manitoba (MAM) has exciting plans for the 2011 year and has created two new subcommittees! Changes have been incorporated in to membership options. Plans are under way to make the Emergency Skills Workshop more inclusive to other maternity care providers and offer professional development workshops. MAM is working towards becoming a 'paperless' association; reducing production of their newsletter and communications on paper. The first step towards this goal is to request that (Health Insurance Reciprocal of Canada) HIROC send out each individual memorandum of Insurance to MAM subscribers by email. MAM will continue to keep an e-copy of each memorandum in their archive database. If you did not receive this from HIROC, please contact MAM.

Membership changes for the 2011 year have included the option of obtaining non-practising insurance with HIROC, which allows for uninterrupted legal defence coverage. This coverage is recommended by HIROC so there are no periods of time a midwife is not insured. Maternity leave, retirement or leave of absence from employment is examples when non-practising insurance is recommended.

The Emergency Skills Workshop (ESW) will be held this year in March, September and October. The ESW committee is interested in opening up the program to other professionals, such as EMS providers, and also to student midwives. The plan is to explore this option to assess level of interest from these groups.

The hope is that this website will meet the needs of membership and be a hub of communication!
